Reporting Home Fire Response Activities

All home fire responses must be called into the Disaster Services Voice Mail at 850/894-6741 between 6:00AM and 10:00PM within 24 hours of completion. Please report the following information:

1. Family name
2. Number of individuals affected
3. Their names, ages and sexes
4. Level of damage (Minor, Major or Destroyed)
5. Location of fire (City and Address)
6. Type of financial assistance provided (\$75.00 Disbursing Order issued for food etc...)

It is extremely important to report your response to home fires so that the Disaster Services Office knows that the individuals and families have received American Red Cross assistance.
