Narrative Report

Monroe County - Monroe County will be evacuating their Special Needs population to a Special Needs Shelter located at Florida International University (FIU) Monday morning. The chapter will be supporting this shelter operation with meals, snacks and limited staffing as called for in the chapter's agreement with Monroe County. The location of the shelter at FIU will be the Charles Perry Building.

Monroe County will be doing an in county evacuation for the general population. The chapter is preparing three (3) ERV's and alerting its catering vendors, volunteers for deployment starting as early as Tuesday morning.

The chapter has placed a fairly large staffing request for support and will also be placing a material resource support request later today.

The Monroe County EOC will be fully activated on Monday.

Miami-Dade County - Currently the chapter has no requests from Miami-Dade County, although the chapter expects to be asked to open shelters for blue tarp roof houses which number in excess of 16,000 currently.

The Miami-Dade County EOC will go to a practical activation on Monday.
