Response Activities

- Red Cross activities of the day as follows:
- Baker County – The chapter’s shelter remains open at the Baptist Church of Glen St Marys. Much donated food and beverages have been donated to firefighters by local people and churches. One (1) ERV was sent to the Baker County Comand Post location this afternoon.
- Bradford county – The shelter at the Madison Baptist Church was closed this morning. It will remain on standby. The county EOC to possibly downgrade no further need for American Red Cross liaison. Feeding and hydrations being done by Division of Forestry and local churches.
- Clay & Putnam Counties – No current threats and no American Red Cross response needed at this time.
