

**STATEMENT OF UNDERSTANDING  
BETWEEN  
CITY OF CHATTAHOOCHEE VOLUNTEER FIRE DEPARTMENT  
AND THE  
CAPITAL AREA CHAPTER OF THE AMERICAN RED CROSS**

**PURPOSE**

The purpose of this Statement of Understanding is to establish a broad framework for cooperation between the City of Chattahoochee Volunteer Fire Department and the Capital Area Chapter of the American Red Cross in planning and preparing for, responding to, recovering from and mitigating disasters. This agreement sets forth a broad framework for cooperation between the two organizations in rendering assistance and service to victims of disasters in the area covered by the Capital Area Chapter of the American Red Cross.

**DEFINITION OF A DISASTER**

A disaster is an occurrence such as hurricane, tornado, flood, tidal wave, drought, residential or commercial fire, wildlands fire, explosion, building collapse, hazardous materials incident, terrorism or tragic event that causes human suffering or creates human needs that victims cannot alleviate without emergency assistance.

**DISASTER RELIEF**

Disaster relief refers to emergency assistance to persons who are deprived of the essential life needs because of a disaster. The purpose of providing such relief is to assist these persons with the basic needs of life until they begin their recovery process.

**TYPES OF DISASTER RELIEF**

The type of services that the Capital Area Chapter will provide to disaster victims is:

- Mass Care (Sheltering)
- Mass Care (Feeding)
- Emergency Family Services
- Disaster Family Well Being
- Disaster Health (Nursing) Services
- Disaster Mental Health Services
- Damage Assessment

**METHODS OF COOPERATION**

Cooperation and coordination between the two entities of this Statement of Understanding in providing disaster awareness education and preparedness programs are agreed to as follows:

**Educational activities relating to fire safety:**

The City of Chattahoochee Volunteer Fire Department and the Capital Area Chapter will work jointly to provide fire safety education to children in Grades Kindergarten through Four.

The City of Chattahoochee Volunteer Fire Department, in consultation with the Capital Area Chapter, will schedule fire safety training classes. The Capital Area Chapter will provide the Fire House or Fire/Weather House on-site with two (2) fire safety instructors.

The Capital Area Chapter will provide fire safety information packets to City of Chattahoochee Volunteer Fire Department to be distributed during the fire safety training classes.

City of Chattahoochee Volunteer Fire Department will promote the partnership with the Capital Area Chapter in any advertising or media coverage related to fire safety training under this joint arrangement.

**Educational activities relating to residents and neighborhoods:**

The Capital Area Chapter will be the lead entity in the partnership with the City of Chattahoochee Volunteer Fire Department in introducing the American Red Cross Disaster Resistant Neighborhood and the Community Emergency Response Team Programs to residents in the community. City of Chattahoochee Volunteer Fire Department will participate in scheduled presentations to provide fire safety information to residents, upon request.

**Emergency assistance to firefighters and other emergency workers:**

The Capital Area Chapter will provide Mass Care (feeding) support to firefighters and other emergency workers during commercial fire or other emergency situation. When the emergency situation is expected to have a duration in excess of two (2) hours, where beverage and food are not easily accessible, City of Chattahoochee Volunteer Fire Department or a representative will contact the Capital Area Chapter to request Mass Care (feeding) support. The request for Mass Care (feeding) support should be made as soon as the duration of an emergency situation can be reasonably predicted.

**Emergency assistance to victims of single-family or multi-family residential fires:**

The Capital Area Chapter can provide assistance to purchase food and clothing for victims of single-family or multi-family residential fires. City of Chattahoochee Volunteer Fire

Department should inquire if the victim(s) if need assistance from the American Red Cross. If assistance is needed, a representative of the City of Chattahoochee Volunteer Fire Department will contact the Capital Area Chapter to dispatch a Disaster Action Team.

**STATEMENT OF UNDERSTANDING MODIFICATION**

This Statement of Understanding can be modified at any time that both entities agree on the modifications and such modifications are reduced to writing and made an addendum to this statement.
